फैसलपुर पर दोस्ती कर 11वीं की छात्रा को भगाने, दुष्कर्म के मामले में भीमगंजमंडी पुलिस ने दो आरोपियों को गिरफ्तार किया है। साथ ही छात्रा को दस्तयाब किया है। आरोपी संदीप चौधरी झुंझनू नवलगढ़ का निवासी है। उसने नाबालिग छात्रा के साथ सोशल मीडिया पर दोस्ती की। फिर कोटा आकर छात्रा को कार में बैठाकर ले गया। शादी का झांसा देकर झुंझनू व नवलगढ़ में ले जाकर दुष्कर्म किया। पुलिस ने सहयोगी कार मालिक व उसके साथी सतवीर को भी गिरफ्तार है। पुलिस ने दोनों को कोर्ट में पेश किया। कोर्ट ने संदीप को 2 फरवरी तक रिमांड पर

भेजा है, जबकि सहयोगी सतवीर को 9 फरवरी तक न्यायिक अभिरक्षा में भेज दिया।

भीमगंजमंडी थानाधिकारी हर्षराज सिंह खरेड़ा ने बताया कि पीड़िता हरियाणा निवासी है, जो कोटा में रिश्तेदार (जीजा) के यहां रहकर पढ़ाई कर रही है। उसकी कुछ दिनों पहले संदीप से सोशल मीडिया

पर दोस्ती हुई थी। साथ कार से कोटा में फुसलाकर साथ ले जाकर 15 फरवरी को कोटा में 11 जनवरी को अपहरण फिलहाल मामले में गिरफ्तार करी है।

उपमहापौर पवन मीणा को रास्ते में धनवा और गौराजी गांव के बीच दो मय किसी वाहन की टक्कर से वे दुर्घटनाग्रस्त हो गए थे। उपमहापौर और मीणा ने बताया कि इटावा निवासी नवल धाकड़ व उनका भतीजा से कोटा लौट रहे थे। उन्होंने घायलों को देखा तो मौके से ही 108 नंबर के बाद दोनों को उपचार के लिए सुल्तानपुर हॉस्पिटल पहुंचाया।
