We wish to inform you that our Company has entered into a PPA for purchase of Solar Power under Captive Open Access through a Special Purpose Vehicle (SPV) i.e Suryadeep RJ1 Projects Private Limited.

Suryadeep RJ1 Projects Private Limited is setting up 15.17 MW (AC)/22MW(DC) Solar Power Plant at Barmer District, Rajasthan under Group Captive Generation Mechanism through open access Solar PV Plant (Built-Own-Operate Model) and our Company has entered into Purchase Power Agreement with them on 5th September 2024. Mangalam Cement Limited shall purchase 26% equity share in the aforementioned Company and shall be investing a sum of Rs7 Crore (Approx). Our Company shall purchase the entire power generated by the Plant as the Captive User. The Plant is likely to be commissioned within a period of 6 months from the date of equity infusion. Accordingly, the Company shall benefit from lower cost of power and would also be complying renewable energy obligations.
